Terms & Conditions:

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Competition is open to all school-age entrants up to 18 years of age who are Australian residents. Entrants under 18 years of age must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to the Terms & Conditions prior to entry submission.
3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Promotion commences on **1/2/2022 at 12.01am** and ends at **11.59pm AEDST on 31/3/2022** ("Promotional Period").
5. To enter, eligible individuals must complete the following during the Promotional Period:

Complete the "Sneaker Design Competition For Schools" Online Entry Form, including uploading a photograph of an original sneaker artwork that the entrant has created. The artwork can be created on any material such as paper, canvas or an actual sneaker.

6. There is no limit to number of entries, individuals can enter as many times as they wish.
7. Winners will be decided by the Promoter. Their parent/guardian and school teacher will be contacted via email or telephone on or before **13/4/2022**.
8. Winners will receive a Liquitex Art Materials Prize Pack for their school, plus a Volley Website Credit. It is the responsibility of the winner's parent/guardian and the winner's school teacher to divide/distribute the Prize Pack.
9. There are 3 x Prize Packs in total. 1st Prize valued at over \$1000 RRP, 2nd Prize valued at over \$250 RRP and 3rd Prize valued at over \$250 RRP. Each Prize Pack contains the following:
